NOW COMES WENDELL H. MARSHALL PRESIDENT OF THE MAPLETON INTERVENERS  
AND TAKES EXCEPTION TO THE "STIPULATION" ENTERED INTO BY AND BETWEEN  
ATTORNEYS FOR THE N. R. C. AND THE APPLICANT, IN SO FAR AS THEY  
FAILED TO COMPLY WITH THE PARAMOUNT AUTHORITY AND THE PREVAILING RULE  
OF PRACTICE WHICH IS UNIVERSAL IN ITS INTERPRETATION AND ITS  
APPLICATION TO ALL, IN THAT THEY FAIL TO COMPLY WITH THE PREVAILING  
RULE TO OBTAIN THE "CONSENT OF THE GOVERNED," BEING THE INTERVENERS  
THEREBY CONSTITUTING AN OFFICIAL ABUSIVE DISCRETION AND RENDERING THE  
"STIPULATIONS" NOT JUST "VOIDABLE" BUT ABSOLUTELY "VOID" FROM THEIR  
INCEPTION TO THEIR CONSUMATION AND IS THEREBY RENDERED  
UNCONSTITUTIONAL. WE THE MAPLETON INTERVENERS NEVER HAVING GAVE OUR  
CONSENT UNDER THE PREVAILING RULE WAIVE ABSOLUTELY NO RIGHTS OF ANY  
KIND OR NATURE WHATSOEVER THEREFORE WE PRAY YOU FIND FOR US AS SET
