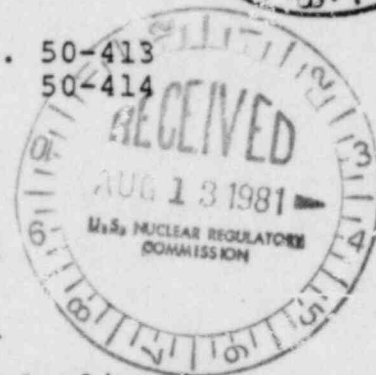
APPLICANTS' 1/ RESPONSE TO THE




