

Dear Bruce:

In our telephone conversations held yesterday afternoon, you requested that PGandE be allowed to submit its responses to Joint Intervenor's First Set of Interrogatories on September 19, 1981 rather than on September 2, 1981 when they are due. I explained our need to have as much of the information as soon as possible in order to prepare and file follow-up discovery to the extent necessary. However, in order to accommodate your request and also to assure that Joint Intervenor's would not, as a result, be deprived of the opportunity to submit further interrogatories or other discovery requests based on PGandE's responses once received by us, I proposed a compromise which would allow PGandE until September 19 to respond and, at the same time, protect Joint Intervenor's interest in adequate discovery. That proposal was rejected by you.

Therefore, I will expect PGandE's responses to our First Set of Interrogatories to be served no later than September 2, 1981.

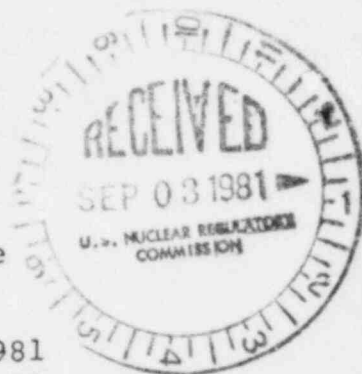
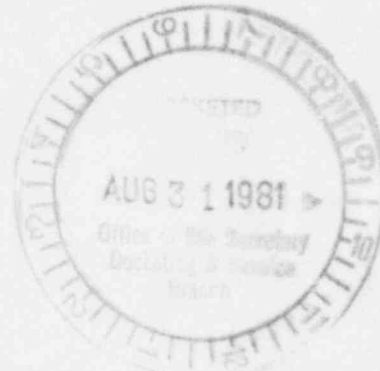
