Identification and Description of Occurrence:

While performing modification on U-1 and U-2 4160 volt shutdown boards, U-2 was made critical from a cold condition with start bus undervoltage relays out of service for the 1A start bus.

Conditions Prior to Occurrence:

Unit 1 refueling outage.

Unit 2 in routine startup.

Unit 3 at 95%.

Action specified in the Technical Specification Surveillance Requirements met due to inoperable equipment. Describe.

Apparent Cause of Occurrence: Personnel error. During preliminary review of modification workplan which contained the removal from service of the 1A start bus undervoltage relays, it was not recognized that the Tech. Spec. 3.9.A.4.e did not permit this activity. There was another separate modification and workplan to be done relating to degraded voltage which existing Tech. Spec did allow. It was recognized start bus initiated logic modification needed to be done at the same time separate degraded voltage modification was being done. However, it was not recognized start bus modification required a Tech. Spec. change which had been submitted to NRC but not approved.

Analysis of Occurrence: There was no danger to the health or safety of the public, no release of activity, no damage to the plant or equipment, and no resulting significant chain of events.

Corrective Action: Undervoltage start bus relays were reconnected immediately upon discovery of the error. This is considered a random event and no further recurrence control is required.
