Enclosed is one copy of Revision 16 to the Callaway Plant Radiological Emergency Response Plan (RERP). This document is approved and is ready to be implemented in accordance with Callaway Plant procedures and 10CFR50.54(q).

This revision is the result of our annual review of the Plan. In addition to minor editing, Letters of Agreement were updated, Protective Action Guides were revised to be consistent with new EPA guidance and directions were added for evacuating non-essential personnel to Reception & Care Centers for monitoring and decontamination, if necessary.

The following Emergency Action Levels (EALs) listed in Chapter Four were also revised:

- EAL 2A Changed the indications to be consistent with Technical Specifications
- EAL 3K,3L Provided additional information to better define when most or all (Annunciators) are lost, and when a Plant transient is initiated or in progress.
- EAL 6A,6B Revised both EALs as a result of recent 10CFR20 changes. The Unusual Event is driven by 10CFR50.72 criteria; the Alert is driven by ten (10) times the Unusual Event values.
