Mr. Constas:

This refers to your request to renew your license dated December 2, 2019. In order to continue our review of your request, the following additional information is needed:

1. Your current license (amendment 5) authorizes 12 portable gauges and your renewal request is asking authorization to possess 4 gauges. Please confirm the quantity of portable gauges you would like authorized on your license.
2. Amendment 5 of your license lists as the RSO John Turner. Please provide copies of training certificates for Steven M. Constas, who is named as the new RSO for your license renewal.
3. Please state that you will either possess and use, or have access to and use, a radiation survey meter that meets the criteria in the section titled, "Radiation Safety Program—Radiation Monitoring Instruments" in NUREG–1556, Vol. 1, Rev. 2, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Portable Gauge Licenses," in the event of an incident.
4. Please state that leak tests will be performed at intervals approved by the NRC or an Agreement State and specified in the SSD registration certificate. Leak tests will be performed by an organization licensed by the NRC
or an Agreement State to provide leak testing services to other licensees; or by using a leak test sample collection kit supplied by an organization licensed by the NRC or an Agreement State to provide leak test kits and/or
sample analysis services to other licensees and according to the kit supplier's instructions. Records of leak test results will be maintained. OR

We will implement the model leak test program published in Appendix I of NUREG–1556, Volume 1, Revision 2, "Consolidated Guidance About Materials Licenses: Program- Specific Guidance About Portable Gauge Licenses." Records of leak tests will be maintained.

5. Please state that you will implement and maintain procedures for routine maintenance of our gauges according to each manufacturer's written recommendations and instructions.
6. Please state the gauge manufacturer or other person licensed by the NRC or an Agreement State will perform nonroutine maintenance or repair operations that require detaching the source or source rod from the gauge.
