The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2018-013 on May 3, 2018, to determine whether documentation required to be maintained per the Entergy firearms maintenance and accountability program was falsified by Entergy employees. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate the concern.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
