Dear Steve:

This will confirm our telephone conversation of yesterday during which I informed you that I represent Mr. John Hughes, a former employee of Pittsburgh Testing Laboratories.

We agreed that NRC officials would not contact Mr. Hughes directly, but that all contact would go through me. I also agreed that I would request Mr. Hughes not to have contact with Mr. Forney unless you were present.

As I told you, Mr. Hughes and his co-workers with whom he was interviewed by Mr. Forney and other Region III officials, gave those officials certain documents pertaining to Mr. Hughes and his allegations. Those documents include but are not limited to tests taken by Mr. Hughes and correspondence regarding his termination by PTL. Because Mr. Hughes did not keep copies of those documents, I request that you immediately provide me with them.

In addition, Mr. Hughes signed a written statement prepared by Region III personnel; inasmuch as he was not given a copy of that statement, I request that you send that to me as well.


