Gentlemen:

This submittal is being provided as clarification for the scheduled completion of the tasks identified in Supplement 1 to NUREG-0737. Our submittal of April 15, 1983 provided the information requested in Generic Letter 82-33. On May 2, 1983, a meeting was held at this site as a follow-up to that submittal to negotiate the schedule in accordance with the direction provided in the Generic Letter. At this meeting and in subsequent telephone conversations, several dates for completion of certain tasks and for the submittal of additional information were established.

The information below represents the most recent conversation between our NRC Project Manager and members of my staff with regard to the SPDS, CRDR, Regulatory Guide 1.97 and EOPs.

SPDS

1. Full implementation of the SPDS will be accomplished following the fifth refueling outage tentatively scheduled for July of 1986.

CRDR

1. The Program Plan will be submitted in September 1983.
2. The Summary Report will be submitted in November 1985.

Reg. Guide 1.97

1. This work activity and development of the final report will be accomplished concurrent with the CRDR. The final report will be submitted in November 1985.


