Attached are 3 originals and 37 conformed copies of a request for change of the Technical Specifications, Appendix A of the Provisional Operating License for the Monticello Nuclear Generating Plant, dated March 11, 1976. This request has been reviewed by the Monticello Operations Committee and the Safety Audit Committee.

The proposed changes deal with an additional containment isolation valve being installed as part of a system for maintaining a constant differential pressure between the torus and the drywell.

We have determined that these changes do not involve an unreviewed safety question.
