**Construction Activities Schedule Six-Month Update for Completion of the  
Inspections, Tests, and Analyses (ITA)**

Ladies and Gentlemen:

In accordance with 10 CFR 52.99(a), Southern Nuclear Operating Company (SNC), as a Combined License (COL) holder under 10 CFR 52, hereby submits the six-month update for completion of the Inspections, Tests, Analyses (ITA) in the Nuclear Regulatory Commission (NRC) approved Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC) for Vogtle Electric Generating Plant (VEGP) Unit 4.

The enclosure to this submittal contains the updated ITA completion schedule for VEGP Unit 4. The ITA completion schedule is based on projected construction activities as of January 23, 2020. The activity dates are established by, and are the property of SNC, and are based on the VEGP Unit 4 integrated project construction schedule.

The ITA completion schedule dates are dynamic as SNC continues to develop schedule granularity through refinement of project coordination, execution and detail level schedule elements. As these refinements are made, they will be reflected in future ITA completion schedules.

The schedule information provided in the enclosure is considered confidential commercial information and exempt from mandatory public disclosure pursuant to the provisions of 10 CFR 2.390(a)(4) and 10 CFR 9.17(a)(4). Following the approach described in SECY-06-0114, no additional withholding determination is needed as the schedule information was demonstrated to be confidential commercial information based on the update provided to the NRC on October 6, 2017 Agencywide Documents Access and Management System (ADAMS) Accession Number ML17279A661. Accordingly, the enclosure should be withheld from public disclosure.
