DEAR CHAIRMAN

THIS IS TO PLACE YOU ON NOTICE, THAT I AM THE VICE PRESIDENT OF  
M.E.P.A. MIDWEST ENVIRONMENTAL PROTECTION ASSOCIATION OF WHOM COLONEL  
GADLER HAS SERVED AS PRESIDENT FOR MANY YEARS. THROUGHOUT THESE MANY  
YEARS IT HAS BEEN GENERAL KNOWLEDGE THAT COLONIAL STEVE GADLER WAS A  
TECHNICAL CONSULTANT ADVISOR FOR THE MAPLETON INTERVENORS, FOR WHICH  
I AM THE PRESIDENT. RECENTLY, MR GADLER AS AN ENGINEER CONSULTANT HAS  
ADVISED US TO LEARN MORE THROUGHOUT THE EFFORTS OF THE NUCLEAR  
REGULATORY COMMISSION REGARDING, "ELECTRO MAGNETIC PULSE" WHICH WE  
HAVE BEEN CURRENTLY PURSUING AS HE HAS NEVER BEEN SEPARATED FROM HIS  
EMPLOYMENT OR SERVICE WITH US. WE WERE RECENTLY THE RECIPIENT OF A  
LETTER FROM JAMES E BRUNNER ESQUIRE OF CONSUMERS POWER CO 212 WEST  
MICHIGAN AVE JACKSON MI 49201 WHO REPRESENTED, AT THE TIME PROPORTED  
TO BE BASED UPON FACTS, THAT HE HAD RECEIVED A TELEPHONE CALL  
INDICATING TO HIM THAT MR GADLER WAS ILL AND THAT AS A RESULT OF HIS  
ILLNESS THEY WERE NOT TO SEND HIM ANYMORE MATERIAL. THEY WERE  
NOTIFYING THE MEMBERS OF THE MAILING LIST THAT HE SHOULD RECEIVE NO  
FURTHER MAIL. THEY DID NOT STATE HIS MATTER OF ILLNESS NOR DID THEY  
STATE IN THEIR LETTER THE SOURCE OF THEIR CALLER OF THE INFORMATION  
OR AS TO WHAT CREDIBILITY OR RELIANCE COULD LEGALLY BE GIVEN  
REGARDING THIS SUPPOSED CALL, OF COURSE I WAS SURPRISED WHEN I  
FORWARDED THE LETTERS TO THE COLONEL. HE GOT MEANER THAN A JUNK YARD  
DOG. HE STATED THAT IT WAS A LIABLE AND SLANDER. HE CLAIMS THAT HE IS  
AGRIEVED AND CHAGRINED AND FEELS THAT HE HAS BEEN INJURED ON A  
NATIONAL BASIS, HE SUGGESTS THAT A SUIT BE BROUGHT AGAINST CONSUMERS  
POWER COMPANY JACKSON MICHIGAN FOR ONE MILLION DOLLARS AND THAT THEIR  
AGENT BE BROUGHT BEFORE THE STATE GREIVANCE COMMITTEE OF THE MICHIGAN  
BAR ASSOCIATION. SINCE COLONEL GADLER IS PRESENTLY ENGAGED AS A  
TECHNICAL CONSULTANT FOR MAPLETON INTERVENORS IT IS NECESSARY THAT AN  
ORDER BE FORTHCOMING IMMEDIATELY TO RESTORE COLONEL GADLER'S STATUS  
QUO THAT HE BE RELACED BACK ON THE MAILING LIST AND ALL THE MATERIALS  
THAT HAVE BEEN TAKEN FROM HIM BY THIS RUSE BE ORDERED MAILED TO "POST  
HASTE". MOREOVER THESE "DIRTY TRICKS" ARE JUST NOT WHAT THEY'RE  
CRACKED UP TO BE AS SOME BONDING COMPANYS WILL SO LEARN IF THIS  
ISN'T SATISFACTORILY TAKEN CARE OF. EVEN A CORPORATION LAWYER SHOULD  
HAVE BETTER SENSE THAN TO INJURE SOMEONE AND RELY UPON A TELEPHONE  
CALL TO JUSTIFY THEIR ACTION TAKEN. I THINK THIS WAS A CONSUMERS  
POWER COMPANY "PUBLIC RELATION DEPT TRICK" SUCH AS THOSE THAT MOAXED

TO REPLY BY MAILGRAM.
