SUBJECT: Application for Amendment of Operating License

Enclosed please find Omaha Public Power District's (OPPD) "Application for Amendment of Operating License" which seeks to amend the Fort Calhoun Station Unit No. 1 Technical Specifications. This change supercedes References 2 and 3 and pertains to the Limiting Condition for Operation (LCO) for the Chemical and Volume Control System (CVCS) and is consistent with previous submittals from the St. Lucie and San Onofre plants.

Attachment A contains a markup reflecting the requested changes of the Technical Specifications. Attachment B provides a Discussion, Justification and No Significant Hazards Consideration Analysis, to include Reference 4 (previously submitted with Reference 2) which was used as a technical basis for the changes required.


