The purpose of this modification is to exercise Option Period 2, Pursuant to FAR Clause 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 2000), the Government hereby exercises its option to extend the term of the task order through April 29, 2021.
