As I believe you are aware from your prior decision on the issue of suspension of the Davis-Besse construction permit during the NEPA review, I am counsel for the Coalition for Safe Nuclear Power. The court ordered suspension hearings were concluded July 8, 1972, and as of July 18, 1972, the record has been returned to the Court of Appeals. The above captioned litigation is presently before the Court and under review. Proceedings on the Petition have been stayed until completion of the final NEPA review by the Atomic Energy Commission.
