Narrative Report  
for LER 50-321/1982-016

On February 13, 1982, while the reactor was operating at steady state power of 1643 MWT and while performing routine surveillance (HNP-7408), the sample pump for noble gas and iodine monitors (MPL numbers 1D11-K632 and 1D11-K633) stalled. This event caused both the monitors to be inop and hence a failure to meet T.S. Section 3.6.G.2. Neither plant operation nor health and safety of the public was affected. This is a non-repetitive event.

The cause of this event has been attributed to a blown fuse. The fuse for the power supply to the pump motor was replaced and the pump returned to service. Upon investigation no definitive cause could be attributed to this event. There is apparently no generic concerns.
