CALLAWAY PLANT, UNIT 2

On April 16, 1976 two Construction Permits, CPPR-139 and CPPR 140, were issued which authorized Union Electric Company to construct a two unit nuclear plant designated Callaway Plant, Units 1 and 2. The application to operate Unit 1 is now under review by the NRC staff.

Delays in Callaway Plant, Unit 2 had caused the scheduled operation date to be moved from 1983 to 1990. On October 9, 1981 Union Electric Company announced that it was cancelling Unit 2. I have attached a copy of the news release relative to the cancellation. The purpose of this letter is to formally notify NRC of the cancellation of the second unit and request that Construction Permit No. CPPR-140 be rescinded as of this date. No NRC Staff review is currently in progress for Docket Number 50-486, therefore this cancellation should not impact the current NRC work load.
