0 6 | in an open position for approximately 48 hours prior to attempting to  
0 7 | close. No previous similar reportable events. No effect on public health

1 2 | decrease opening force and increase friction) and possible residual core  
1 3 | magnetism. All purge and vent valve solenoids replaced with new  
1 4 | valves mounted vertical i.a.w. vendor instructions.
