Dear Mr. Denton:

Enclosed in my March 22, 1982, letter to you concerning Technical Specifications was a proposed Specification 3.6.1.6, "Containment Structural Integrity." Mr. N. D. Romney of the NRC reviewed this submittal and made several comments. On April 23, 1982, Mr. Shealy of SCE&G Company and Mr. Fulton of Gilbert Associates, Inc. held a conference phone call with Mr. Romney to resolve his comments.


As a result, enclosed is a revision to the above proposed Specification 3.6.1.6. The revision consists of the addition of three new paragraphs identified by vertical lines in the righthand margin and the deletion of the last paragraph under Surveillance 4.6.1.4.1c pertaining to the  $\pm 3\%$  requirement and the footnote to Table 4.6-1a.

The requirements of Surveillance 4.6.1.6.1.b are not in Regulatory Guide 1.35 but are based on the proposed Subsection IX of Section XI of the ASME Code prepared by the Working Group on Concrete Pressure Components. For information pages 16 and 17 of this document are enclosed as Attachment I.

Although not changed in this submittal the lower limits found in Table 4.6-1a/4.6-1b may require additional revision. After the development of the first tendon surveillance evaluation (performed February - April, 1982) we will provide you with any changes in the lower limits we feel are appropriate and the justification for these changes.
