

AFFIDAVIT OF ROBERT A. BRUGDEN

I am Robert A. Brugden and I live at 200 Broad St., Carrboro, N.C. This place is within 50 miles of the Shearon Harris Nuclear Power Plant. I also work within 50 miles of the Shearon Harris Nuclear Power Plant site.

I am a member of the Kudzu Alliance, I have authorized Kudzu Alliance to petition to intervene on my behalf in the Operating License application by CP&L and others, and to represent me and my interests which may be adversely affected by the operation of the Shearon Harris Nuclear Power Plant. I do not believe my interests will be adequately protected or represented by other parties.

If the Shearon Harris Nuclear Power Plant gets a license to operate, I believe my health and safety can be adversely affected by routine and accidental releases of radioactive material, (and by psychological stress related to nuclear waste, nuclear accidents, routine releases of radioactive material, and CP&L's poor record as an operator of nuclear plants, and knowing that these can cause cancer, birth defects, genetic damage to future generations, aggravate diseases, and cause injury or death) and that my

property, job and financial interests may be jeopardized by the nuclear plant's operations and by possible accidents and "normal" releases of radioactive material from it. I grow some of our own food, at my home which is within 50 miles of the Harris nuclear plant site, which could be contaminated by radioactive material escaping from the plant. I join in requesting the NRC to financially aid us in our intervention against this billion-dollar utility and its nuclear plant.
