Narrative Report
for LER 50-321/1982-037

On 4/22/82 a security officer coming on duty attempted to bring a .22 caliber automatic revolver through Security Headquarters and into the protected area whereupon the metal detection device alarmed; the individual was scanned by a portable metal detector and the weapon was identified. The officer stated that his weapon was made of zinc, and he wanted to determine if the metal detection device would detect it. He was instructed to return the weapon to his vehicle. Upon re-entry, the detection devices alarmed again, the officer was scanned and the clip of ammunition from his weapon was discovered in his pocket. The officer was sent home pending completion of an investigation. Further investigation led to the subsequent termination of his employment on 4/28/82. This event was reported on Deviation Report 1-82-70.
