Millstone Nuclear Power Station, Unit No. 3  
Revision 3 to the Updated Final Safety Analysis Report

In 1987, <sup>(1)</sup> Northeast Nuclear Energy Company (NNECO) submitted the initial updated Final Safety Analysis Report (FSAR) for Millstone Unit No. 3 since receipt of the Operating License in fulfillment of the requirements of 10CFR50.71(e). This rule further requires that subsequent revisions of the FSAR shall be filed no less frequently than annually, and shall reflect all changes up to a maximum six months prior to the date of filing. <sup>(2)</sup>

Pursuant to 10CFR50.71(e)(4), as Attachment 1, NNECO hereby presents the Staff with Revision 3 to the updated FSAR. This revision is provided in the form of replacement pages as required by 10CFR50.71(e)(1) and (5). This revision presents changes completed since our previous submittal necessary to reflect information and analyses submitted to the Commission or prepared pursuant to Commission requirements as of December 31, 1989. Pursuant to 10CFR50.71(e) and 10CFR50.4(b)(6), this transmittal consists of one original and ten copies.

It is noted that 10CFR50.71(e)(2)(ii) stipulates "This submittal shall include an identification of changes made under the provisions of Section 50.59 but not previously submitted to the Commission." Pursuant to Section 50.59(b),


such information is routinely submitted to the NRC as part of our annual reports and is not included in this submittal.


