NOTICE OF VIOLATION

Dear Ms. Minchak:

On February 4, 2020, the U.S. Nuclear Regulatory Commission (NRC) cited CH2M Hill, Inc., for a violation involving the failure to review radiation and contamination surveys for accuracy and completeness. NRC Inspection Report 030-39123/2019-001 with enclosed Notice of Violation (Notice) required a written reply within 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession ML20035E036). In a letter dated February 26, 2020, you provided your reply to the Notice (ML20065G221).

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
