
South Carolina Electric and Gas Company (SCE&G), acting for itself and as agent for South Carolina Public Service Authority, submits the following:

1. Amendment 9 to the Virgil C. Summer Nuclear Station (VCSNS) Physical Security Plan. It includes commitments to specific alarm rates and other miscellaneous changes. This amendment contains no changes which would decrease the safeguards effectiveness of the Plan and is therefore submitted under the provisions of 10CFR50.54(p).
2. Replacement pages for the entire VCSNS Physical Security Plan. These pages were retyped to improve format, readability, etc., and are not considered to constitute a revision to the Plan.
