0 4 | On January 28, fire door OC709 (189 feet elevation Control Building) was blocked
0 5 | open to support planned maintenance. Hourly fire watches were established in
0 6 | accordance with T.S.3.7.7. The event had no effect on the health and safety of
0 7 | the public and did not constitute a threat to plant safety. The event is reported
0 8 | pursuant to T.S.6.9.1.13.b.
