EVENT DESCRIPTION AND PROBABLE CONSEQUENCES (10)

02 While in mode 6, analysis of a representative fuel pool ventilation system (VF)  
03 carbon filter sample per T.S.4.9.11.2(b) indicated the sample failed to meet  
04 the penetration criteria of methyl iodide of less than 1 percent. The VF System  
05 was declared inoperable per T.S.3.9.11 which is reportable per T.S.6.9.1.11(d),  
06 and similar to RO-369/82-43. Until a final determination of VF carbon adsorber  
07 operability is made the system will remain inoperable, and fuel movement and  
08 crane operation with loads suspended. Health and safety of the public were  
09 unaffected.

10 Analysis of a sample (with run time of 714.9 hours) by vendor "B" failed the  
11 test (6.54 percent penetration). Analysis of a sample (longer run time of  
12 1192.6 hours) by vendor "A" passed (0.6 percent penetration). Another sample  
13 will be analyzed by a third vendor to determine if it was vendor error or filter  
14 failure. If consensus analysis is failure, bed will be reloaded. A followup  
15 report will be submitted.


