Re Order regarding Quality Assurance Documents May 13, 1983, AWPP (Romano) is sending copy of IE Report No. 50-353/76-06, the related Notice of Violation and Applicant's (Vincent Boyer) response thereto with attachment.

I want to comment on the point of "other documents made available to Mr. Romano" (Applicant's Answer [to contention] April 27, 1983 at 43) (sic) hearing on the scope of re-examination of welds inspected by the particular inspector as per order dated May 13, 1983, which I received May 18, 1983.


There are abundant other IE reports and notices of Violation re welding infractions (see copies submitted).

Also as it relates to IE50-353/76-06, in the January 11, 1983 letter under Discovery 2 by Mark Wetterhahn, Esq., in response to my letter of Sept. 3, 1982 to Troy Conner, Jr., Esq., re Docket 352-3 (contention VI-I)...in particular "Enclosure 2", interrogatories on Welding Infractions

- (a) re items (1),(2),(3), did not provide answers to questions asked.
- (b) re items (4),(5),(6) under Wetterhahn Discovery 2, (10) response was "Company is exploring conditions for answers" which I have not received.
- (c) re item (7) Wetterhahn under Discovery 2, (11) states "documents are being provided", however, specific, recognizable answers were not evident.
- (d) re item (8) Wetterhahn letter under Discovery 2, (12) re 76-06-01-QCIR-W-1-8 copy made available but not pertinent to solution.

As per Applicant's answer [to contention], April 27, 1983 it is stated, "As set forth in documents made available to Mr. Romano, All welds (Applicant's emphasis) inspected by the particular inspector, not only accessible welds (emphasis by Romano) were examined. Contrary to Mr. Wetterhahn's statement, however nowhere has the Applicant demonstrated that all welds, not only accessible welds were examined. Specific requests for number of welds and percentage of those inspected were not available in responses.
