WE ARE DEEPLY DISTURBED THAT THE COMMISSION HAS DIRECTED THE INDIAN
POINT ASLB TO NARROW THE SCOPE OF ITS INVESTIGATION. WE ARE
ESPECIALLY CHAGRINED BECAUSE THE INTEREST OF OVER 7 MILLION NEW YORK
CITY RESIDENTS WHO LIVE "NEARBY" INDIAN POINT MAY NOT BE CONSIDERED
AS A RESULT OF THE COMMISSION ORDER.

FOR THE REASONS CLEARLY ARTICULATED IN COMMISSIONER ASSELSTINE'S
DISSENT, WE URGE THE NRC TO RESCIND ORDER CLI-82-15 AND TO GRANT THE
RESIDENTS OF NYC THE OPPORTUNITY TO BE FULLY HEARD, DUE PROCESS
REQUIRES NO LESS. THE PUBLIC DEMANDS NO LESS.
