Revision 12 to the Updated Final Safety Analysis Report

In 1982,⁽¹⁾ Northeast Nuclear Energy Company (NNECO) submitted the initial updated Final Safety Analysis Report (FSAR) for Millstone Unit No. 2 in fulfillment of the requirements of 10CFR50.71(e). That rule, as amended, further requires that subsequent revisions to the FSAR shall be filed annually, or six months after each refueling outage, provided the interval between successive updates to the FSAR does not exceed 24 months. The FSAR update shall reflect all changes up to a maximum of six months prior to the date of filing.⁽²⁾

NNECO hereby submits Revision 12 to the updated FSAR in the form of replacement pages as required. Pursuant to 10CFR50.71(e)(2)(i), I certify that this revision accurately presents changes completed since our previous submittal that are necessary to reflect information and analyses submitted to the Commission or prepared pursuant to Commission requirements, as of December 31, 1993.

- (2) To meet the annual submittal requirement, NNECO has provided an FSAR revision by June 30 of each year.
