Proposed Schedule for Reopened Hearings on

Members of the Appeal Board:

There have been numerous discussions between the parties to this matter regarding scheduling for the reopened hearings on design quality assurance. Those discussions, while not leading to total agreement, have resulted in general agreement as between the Applicant, Staff and Governor of California. It is Applicant's understanding that the Joint Intervenor are in essential disagreement as to the schedule set forth below and would propose that it be extended at least six weeks.


