SUPPLEMENTAL INFORMATION FOR CAUSE
DESCRIPTION AND CORRECTIVE ACTIONS

Although this action permitted Train B RCS Subcooling Margin Monitor to be returned to operable status in accordance with Procedure SO23-3-3.35, the isolation of 3RT-7820-2 rendered it inoperable and thus the plant remained in the associated LCO 3.3.3.6 Action Statement. Actions to restore the monitor to operable status were immediately begun. However, the plant entered Mode 4 on March 7, 1983 at 1409 and is currently in Mode 5. 3RT-7820-2 will be returned to operable status within the time constraints of the applicable LCO when Mode 3 is re-entered.

As corrective action to prevent recurrence of this event, an engineering evaluation will be conducted to determine the feasibility of installing ground isolation modules in instruments interfacing with the QSPDS to prevent an instrument ground from affecting the operation of the QSPDS.
