1994 Annual Emergency Preparedness Exercise Scenario

Gentlemen:

This letter submits the scenario package for the Limerick Generating Station (LGS), Units 1 and 2, 1994 Annual Emergency Preparedness Exercise. The exercise is scheduled to be conducted on Tuesday, November 22, 1994, and involves limited participation from offsite emergency response agencies. This information is being submitted 60-days prior to the scheduled exercise date as specified in an NRC letter dated August 9, 1989, regarding the submittal of "Emergency Exercise Objectives and Scenario Guidelines."

The August 9, 1989 letter, provides instructions for submitting Annual Emergency Preparedness exercise objectives and scenario information. In the past, PECO Energy Company has followed the guidance delineated in the August 9, 1989 letter, and has provided the appropriate information to the NRC for review in order to support the planning and performance of emergency exercises at LGS. However, as a result of subsequent telephone conversations with NRC Region I representatives and the NRC resident inspector at LGS, the NRC indicated that as a result of the new inspection criteria, only the resident inspector will be involved in reviewing emergency exercise related information for this limited participation Emergency Preparedness exercise. Arrangements for submitting the emergency exercise information will be negotiated between the NRC Resident Inspector and PECO Energy's Emergency Preparedness group. Therefore, we are submitting the 1994 Annual Emergency Preparedness exercise scenario package to the LGS NRC Resident Inspector only for review.
