Dear Mr. O'Reilly:

In response to Mr. R. C. DeYoung's letter on May 13, 1983, transmitting IE Bulletin 83-05, ASME Nuclear Code Pumps and Spare Parts Manufactured by the Hayward Tyler Pump Company, Carolina Power & Light Company performed a review of purchase orders issued since 1977 to determine if Hayward Tyler pumps or spare parts were procured for the Brunswick station. In addition, site system descriptions, foreign prints, and vendor manuals were reviewed to determine if Hayward Tyler components were used. To the best of our knowledge, based upon the scope of the reviews conducted, neither Hayward Tyler pumps nor spare parts are used at the Brunswick station. We trust that this information satisfies the request of IE Bulletin 83-05.
