Regarding The Incorporation of NRC Generic Letter 87-09

Gentlemen:

Attached for your review and approval are proposed changes to the ANO-2 Technical Specifications incorporating the recommendations of Generic Letter 87-09. These changes revise Limiting Conditions for Operations Sections 3.0.4, 4.0.3 and 4.0.4, their associated Bases and those associated Technical Specifications, which will no longer need to be exempt from the provisions of Technical Specification 3.0.4 due to its rewording.

In accordance with 10CFR50.91(a)(1), and using the criteria in 10CFR50.92(c), Entergy Operations has determined that the changes involve no significant hazards consideration. The basis for this determination is included in the enclosed submittal. This submittal is being made in accordance with the Staff's request dated April 10, 1991 (2CNA049103). These changes will remove unnecessary restrictions on plant operations.

We request that the effective date for these changes be upon issuance of the amendment to allow ANO-2 to take immediate advantage of these improvements.
