Subject: Entergy Fleet (Grand Gulf and River Bend) - Acceptance Review of LAR Associated with Adopting TSTF-501, "Relocate Stored Fuel Oil and Lube Oil Volumes to Licensee Control" (EPID L-2020-LLA-0032)

By letter dated February 26, 2020 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML20057G004), Entergy Operations, Inc. (the licensee) submitted a license amendment request (LAR) to revise Technical Specifications (TSs) to adopt Technical Specification Task Force (TSTF) Traveler TSTF-501, "Relocate Stored Fuel Oil and Lube Oil Volumes to Licensee Control," Revision 1 (ADAMS Accession Nos. ML090510686 and ML100850094), for Grand Gulf Nuclear Station (Grand Gulf) and River Bend Station (River Bend), Unit 1. The proposed LAR will revise Grand Gulf and River Bend TS 3.8.3, "Diesel Fuel Oil, Lube Oil, and Starting Air" by removing the current stored diesel fuel oil and lube oil numerical volume requirements from the TSs and placing them in the TS Bases so that they may be modified under licensee control. The TSs are also revised such that the stored diesel fuel oil and lube oil inventory will require that a 7-day supply be available for each diesel generator at Grand Gulf and River Bend. Corresponding Surveillance Requirements and TS Bases are also revised to reflect the above changes.

The purpose of this e-mail is to provide the results of the U.S. Nuclear Regulatory Commission (NRC) staff's acceptance review for the LAR. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical review. The acceptance review is also intended to identify whether the application has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

The NRC staff has reviewed your application and concluded that it does provide technical information in sufficient detail to enable the NRC staff to complete its detailed technical review and make an independent assessment regarding the acceptability of the proposed LAR in terms of regulatory requirements and the protection of public health and safety and the environment. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may be instances in which issues that impact the NRC staff's ability to complete the detailed technical review are identified despite completion of an adequate acceptance review. You will be advised of any further information needed to support the NRC staff's detailed technical review by separate correspondence.

Based on the information provided in your submittal, the NRC staff has estimated that this licensing request will take approximately 150 hours to complete. The NRC staff expects to complete this review by March 29, 2021, or earlier. If there are emergent complexities or challenges in our review that would cause changes to the initial forecasted completion date or significant changes in the forecasted hours, the reasons for the changes, along with the new estimates, will be communicated during the routine interactions with the assigned project manager. These estimates are based on the NRC staff's initial review of the application and they could change, due to several factors including requests for additional information, or unanticipated addition of scope to the review.
