
Gentlemen:

Attached are Technical Specification change requests for your review and approval. These changes will allow operations with the proposed expansion of spent fuel pool storage capacity.

The application for amendments to the Arkansas Nuclear One Unit 1 (ANO-1) and Unit 2 (ANO-2) Facility Operating Licenses to authorize spent fuel pool storage capacity was transmitted to Mr. H. R. Denton by letter dated November 5, 1982 (ØCAN1182Ø5). A detailed description of the proposed changes to spent fuel pool storage facilities and operations was transmitted with the request for amendment.

Pursuant to 10CFR Part 170, Section 170.22, these proposed changes are considered to be a Class IV amendment. Accordingly, a check in the amount of \$12,700 is remitted.




