The Board's "Memorandum and Order Continuing Informal Discovery, Providing for Further Specification of Conditionally Admitted Contentions and Noting Dismissal of ECNP" dated February 10, 1983 was served by the NRC's Public Proceedings branch on February 15, 1981 and only received by us on February 17, 1983. In this regard, I would suggest to you a procedure used by other licensing boards by which "courtesy" copies of


