We have reviewed the above-referenced letter in which you propose to appoint Bechtel Power Corporation as the new constructor of the William H. Zimmer Nuclear Power Station, Unit #1.

Before the National Board Audit Team can make a recommendation to the State of Ohio Department of Industrial Relations, we request that you present to the National Board Audit Team a program which will describe in detail how CG&E, Bechtel and HJK intend to accomplish the stated purpose of your referenced letter.

In addition, it is requested that your program identify by specific reference to the applicable ASME Code paragraph how CG&E, with Bechtel and HJK, will accomplish the objectives which you state.
