APPLICANT'S MOTION TO STRIKE CONTENTION 2

Applicant Carolina Power & Light Company hereby moves the Board to strike Contention 2 as moot.

In its Notice of Hearing dated December 2, 1983, the Board referred to its previous Memorandum and Order of April 12, 1983, which admitted inter alia Hartsville Group's Contention 2, in establishing the issues to be litigated at the hearing to commence on February 7, 1984. Contention 2 asserts that the National Environmental Policy Act requires the NRC Staff to prepare an environmental impact statement prior to issuance of amendments to the Robinson Unit 2 operating license authorizing replacement of steam generators. In admitting Contention 2, the Board noted: "Should Staff's environmental appraisal lead to preparation of an EIS, the contention will be rendered moot and stricken." April 12 Memorandum and Order at 7.

The NRC Staff has prepared and issued its "Final Environmental Statement related to Steam Generator Repair at H. B. Robinson Steam Electric Plant, Unit No. 2", NUREG-1003 (November 1983). Contention 2 is thereby moot.


During a conference call on this date, counsel for the Staff and a representative of the Hartsville Group authorized Applicant's counsel to represent that they concurred in this Motion to Strike.


