TITLE OF THE EVENT: EMERGENCY BUS DEGRADED/UNDervOLTAGE PROTECTION

1. Description of the Event

During a review of EMP-P-RT-85 and 87 (performed during the last refueling shutdown) it was discovered that the degraded voltage relays for 2J bus "C" phase and 2H bus "A" phase, and the undervoltage relays for 2J bus "B" phase and 2H bus "A" phase were set below the limits specified in Technical Specification Table 3.7-4. This is contrary to Technical Specification Table 3.7-2 and is reportable in accordance with Technical Specification 6.6.2.b.(1).

2. Probable Consequences and Status of Redundant Equipment

In the event of a loss of power to one or more of the 4KV bus, these undervoltage and degraded voltage relays provide for the automatic start of the Emergency Diesel generators. During this event, two of the three channels remained operable. Therefore, the health and safety of the public were not affected.

3. Cause

The cause of this event is instrument drift.

4. Immediate Corrective Action

The relays were reset to the Technical Specification limits.

5. Subsequent Corrective Action

No further actions were required.

6. Action Taken to Prevent Recurrence

None.
