

Pursuant to 10CFR50.73, Houston Lighting & Power submits the attached Unit 1 Licensee Event Report 95-06 regarding a failure to meet the requirements of Technical Specifications due to not performing a required surveillance on a Hydrogen Recombiner in July, 1992. Subsequent testing verified that the Hydrogen Recombiner functioned appropriately. This occurrence did not have an adverse effect on the health and safety of the public, but clearly does not meet the standards for expected operational performance.
