Dear Administrative Judges:

On Friday, April 20, 1984, I informed you via letter that Suffolk County was unable to submit testimony on LILCO's Low Power Motion by the April 20 date established by the Board. I stated that "[t]he County will shortly submit affidavits of its experts which document further the fact that under the restrictive schedule established by the Board's April 6 Order, it was impossible for the County to submit prefiled testimony and present the affirmative case which it wished to do on behalf of its citizenry."


