receipt of apparently fraudulent materials sold by Ray Miller, Inc.

Based upon further review we find it necessary to amend the
Quad Cities response included in Reference (d). Four 10-inch, 900
lb., schedule 80 flanges were purchased from Midland Pipe & Supply
Company in 1978. It has been determined that these flanges were
procured by Midland from Ladish Company. This material, therefore,
has no connection with Ray Miller, Inc.
