Enclosed are:

The enclosed document; WAPWR RESAR SP/90, PDA Module 2, "Regulatory Conformance"; is the second in a series of modular PDA documents planned for submittal over the next thirteen months. The number of copies submitted were agreed to via discussion with the NRC Special Projects Branch (Mr. G. C. Meyer).

This Regulatory Conformance module is an updated version of the "Licensing Control Document" submitted via reference 1. It has been prepared to ensure that both current and anticipated licensing requirements and guidance are considered as an integral part of the WAPWR design in response to new or potential future licensing requirements, and indicates Westinghouse design, analysis/evaluation, and licensing documentation intentions for the WAPWR.

Westinghouse requests that the NRC staff review this document from the standpoint of (1) completeness in addressing new or potential future licensing requirements, and (2) adequacy of the Westinghouse interpretation and response to these licensing requirements.


