Attached is a reportable occurrence which relates to the Palisades Plant and has been classified as a condition leading to operation in a degraded mode. Plant Technical Specifications permit operation to continue for 12 hours with unidentified primary coolant system leakage between 1 and 10 gpm. Leakage was identified at a sample isolation valve.
