THIRD SUPPLEMENTAL ORDER

The Committee, in its Second Supplemental Order dated June 30, 1995, adopted a proposed plan for updating the Nuclear Decommissioning Financing Fund for Seabrook Station and ordered that the North Atlantic Energy Service Corporation file a revised funding schedule consistent with its Report and Order within thirty (30) days of the Order.

North Atlantic Energy Service Corporation complied with the order and filed a revised funding schedule consistent with the Committee's Order on July 13, 1995.






ORDERED, that the Committee accepts and approves the revised funding schedule as filed by North Atlantic Energy


• Service Corporation on July 13, 1995, and hereby incorporates it by reference into and as a part of the Committee's Report and Order dated June 30, 1995.




