In response to a request by Mr. D. Schnell of the Union Electric Company, Mississippi Power & Light Company (MP&L) submitted AECM-84/0119, dated March 8, 1984, which included two attachments. The first attachment supplied information on operating staff experience by job title. The second attachment provided the experience levels of MP&L's proposed five operating shifts. The purpose of this letter is to update the information provided in Attachment 1 to AECM-84/0119.

Since the issuance of AECM-84/0119, MP&L has been informally advised by the NRC that two operators, who previously held reactor operator licenses, have been granted senior reactor operator licenses. As a result of this, these two operators have been upgraded from Control Room Operators to Shift Supervisors. The attachment to this letter reflects this new information and, therefore, supersedes Attachment 1 to AECM-84/0119. A review of the attachment to this letter clearly demonstrates MP&L's ability to staff five operating shifts.
