AUDIT FINDING NO. 1

In order to proceed with the audit, it was decided to discuss with Ebasco the deconvolution analysis for the plant. This issue was previously raised in review of the FSAR. Ebasco has applied the deconvolution methodology to a finite element model of the rock site. Since the rock is essentially elastic, in the range of interest, a reduction in motion at the base mat from that postulated at the surface would not be expected. In the analysis, credit was taken for such a reduction and the staff has disagreed that such results would not be expected for a rock site.

Accordingly, the staff will require that the recommendations of NUREG 0800, Section 3.7.2 will be followed. Specifically, either an elastic half-space analysis should be performed to confirm the finite elements analysis, or the site should be considered as a rock site, and a fixed-base analysis should be performed. In any case, the full value of the SSE/OBE should be input at the base mat without reduction.

RESPONSE TO FINDING NO. 1

An elastic half-space approach of seismic dynamic analysis of Category I structures has been performed in response to the staff's request. The analysis results confirm the acceptability of the finite element/boundaries approach employed for the WNP-3 seismic design.

The details of the elastic half-space analysis and comparison of the analysis results to the WNP-3 design basis are presented in Attachment 1.
