PROPOSED CHANGES TO TECHNICAL SPECIFICATIONS  
3.4.4 AND 3.4.9.3

Georgia Power Company (GPC) letter ELV-02517 dated November 18, 1991, requested changes to Technical Specifications 3.4.4 and 3.4.9.3. In response to a verbal request from the NRC staff, this letter provides additional information and clarification of the Technical Specifications changes. Since the proposed changes to these two specifications are independent of each other, the proposed changes have been reformatted so they can be reviewed separately. Attachment 1 addresses the requested changes to Specification 3.4.4. Attachment 2 addresses the requested changes to Specification 3.4.9.3. Each attachment contains the following enclosures: enclosure 1 describes the proposed changes and gives the basis for the changes, enclosure 2 provides an evaluation of significant hazards according to 10 CFR 50.92, and enclosure 3 provides instructions for incorporating the proposed changes into the Technical Specifications and includes the proposed changes.

The proposed Technical Specifications changes that were previously submitted with letter ELV-02517 have been divided into two independent changes. This will allow them to be considered separately. Therefore, the attachments to this letter should be used to completely replace the enclosures to letter ELV-02517.

In accordance with 10 CFR 50.91, the designated state official will be sent a copy of this letter and all enclosures.
