
To ensure compliance with te 10CFR73.21, the pages removed must be destroyed by shredding, burning or cutting into 1/2 inch pieces or smaller.

These changes are being made as the result of an NRC Letter dated February 23, 1984, which rejected certain portions of Revision 13 to the Security Plan.

Page C-4 is reverting back to Revision 8 which was the previously approved wording because the Commission considered the change submitted as decreasing the effectiveness of the Plan and, therefore, must be submitted as an amendment to the license per 10CFR50.90.

Page D-8 was reworded to make it acceptable to the Commission and resubmitted under the provisions of 10CFR50.54(p).
